



## Schedule of Fees for 2010-2011

**Application Fee:** \$150.00 due at time of re-enrollment or application (non-refundable).  
 For those re-enrolling, a \$100.00 credit will be posted prior to re-enrollment the following year (February 2011 statement) if the fee is paid by the re-enrollment deadline of February 26, 2010.

**Tuition: Yearly** – Note: discounted rates are based on financial need and must be requested. Please see Multi-child Discount Form to see if you qualify.

**Tuition: Monthly** tuition is based on 12 monthly payments beginning in June through May. There is a \$10.00 monthly (\$120 annual) charge per family for monthly payments. (Due on 1<sup>st</sup>, **late on the 10<sup>th</sup> \$40.00 fee**)

### **½-Day Program:**

Pre Kindergarten (K4) & ½-day Kindergarten \$234.33

Note: If oldest child add the \$10.00 fee to tuition amount.

There is 4% discount for tuition paid in full by June 15th. Semi-annual payments (50% June 15 and 50% December 15) will not be charged the \$10.00 monthly fee.

Multi-child discounts are based on financial need and must be requested. If 10% of your gross combined family income is less than your families' tuition, then you qualify for multi-child discounts. For example, if a family has a 4<sup>th</sup> grade and 2<sup>nd</sup> grade student the tuition is \$9,380.00. If the family makes less than \$93,800.00, then they qualify for the second student discount. Please complete the Multi-child discount form.

1<sup>st</sup> student (oldest child of family enrolling) is in the highest-grade level and each additional student is in descending grade order. Pre-kindergarten (K4) ½ day and full day and ½ day kindergarten students are not considered in discounting of tuition.

Example: Three students (grades 6<sup>th</sup>, 4<sup>th</sup>, and K4 enrolled at MCA). The tuition would be figured as follows:

1 <sup>st</sup> student - \$4,976.00 (6 <sup>th</sup> grader)
2 <sup>nd</sup> student - \$4,095.00 (4 <sup>th</sup> grader)
3 <sup>rd</sup> student - \$2,812.00 (K4 ½ day– not discounted)

**Withdrawal:** Should you decide to withdraw prior to August 1, 2010 and **not** contact our office, there will be a one half month's tuition fee due per student (12 month payment plan). All fees must be paid prior to forwarding any records.

**Before & After School Care:**

Before school care is available from 6:30 AM to 8:00 AM (school children only).

After school care is available from 3:40 PM to 6:00 PM (school children only).

**After Care Charges:** ASC is \$2.00 per half hour per student, unless a prepaid ASC card is purchased at 20 half hours for \$30.00, 50 half hours for \$50.00 or monthly unlimited at \$70.00 per student per month. Note: The balances of these cards are not carried over to the following year.

**Lunch Charges:** Lunch is \$4.25 per day per student, except if you have purchased our prepaid lunch cards of 10 lunches for \$35.00 per student per card or 20 lunches for \$65.00 per student per card. Milk for the semester is \$32.50 or \$62.50 for the year.

**Late Fees:** A late fee of \$30 will be assessed to all account balances that are past due. **Tuition is due on the 1st of the month, late charges are assessed after the 15<sup>th</sup>.** Accounts that are 45 days past due must be made current or have a payment plan approved. Students will be excluded from school until these conditions are met.

**Pastor's Tuition Discount:**

A fifty percent (50%) tuition discount may be allowed for a full-time pastor, as defined by the IRS code, who is employed in a traditional church ministry. A twenty-five percent (25%) discount may be allowed for a full-time pastor, as defined by the IRS code, who is employed in any ministry other than a traditional church ministry. **An annual letter from the church governing board must be submitted with your application for enrollment/re-enrollment.**

In addition to the multi-child discount MCA offers need-based financial assistance to those who qualify through Family Financial Needs Assessment services. Applications are available in the billing office or online at **www.ffna1.com**. The financial aid application must be mailed for processing no later than **April 1, 2011** prior to the fall enrollment in which you are seeking assistance in order to be guaranteed consideration. If funds are available, applications submitted after the deadline may receive consideration.
