Application Fee: \$150.00 is due at the time of application. It is non-refundable unless the student is denied admission.

Pre Kindergarten (K4) & ½-day Kindergarten \$248.00
Note: If oldest child add the \$10.00 fee to tuition amount.

Tuition: Monthly tuition is based on 12 monthly payments beginning June 1, 2011 and completed by May 1, 2012. There is a \$10.00 monthly (\$120 annual) charge per family for monthly payments. Annual tuition paid in full by June 10th will be discounted 4%. Semi-annual payments can be made (50% June 10 and 50% December 10) and will not be charged the \$10.00 monthly fee.

Before & After School Care:

Before school care is available from 6:30 AM to 8:00 AM. After school care is available from 3:40 PM to 6:00 PM. (The program is for MCA students only.) The cost is \$2.00 per half hour per student, unless a prepaid card is purchased at 20 half hours for \$30.00, 50 half hours for \$50.00, or monthly unlimited at \$70.00 per student per month. **Full-day Pre-Kindergarten and Kindergarten students are not charged for before and after school care.**

Lunch Charges: Lunch is \$4.25 per day per student, unless you have purchased a prepaid lunch card of 10 lunches for \$37.50 per student per card or 20 lunches for \$70.00 per student per card. Milk for the semester is \$35.00 or \$67.50 for the year.

Late Fees: A late fee of \$40 will be assessed on all account balances that are past due. **Tuition is due the 1st of the month, late charges are assessed after the 10th.** Accounts that are 45 days past due must be made current or have a payment plan approved. Students will be excluded from school until these conditions are met.

In addition to the multi-child discount, MCA offers need-based financial assistance to those who qualify through FACTS Grant and Aid Assessment services. If you have questions about the application process you can call (866) 315-9262. **All applications are made online** (computers are available here at the school for your convenience) at www.factstuitionaid.com. The financial aid application must be completed by **April 1, 2011** prior to the fall enrollment in which you are seeking assistance in order to be guaranteed consideration. If funds are available, applications submitted after the deadline may receive consideration.

Withdrawal: Should you decide to withdraw prior to August 1, 2011 and **not** contact our office, there will be one half month's tuition fee due per student (12 month payment plan). All fees must be paid prior to forwarding any records
